SUMMARY OF ORDERS IN THE ABOVE CASE


NOW, on this 16th day of February, 2005, after being advised in the premises, and/or upon evidence offered, and upon argument of the parties, the court hereby finds that the Defendant's:


1. Motion in Limine to Prohibit & Exclude Any and All Reference to Any Video Tape Evidence is sustained and granted.
2. Motion to Suppress the State's Breath Test Results, Breath Test Logs & Breath Test Affidavit is sustained and granted.
3. Motion in Limine to Prohibit & Exclude Any and All Post Arrest Statements by Defendant is sustained and granted
4. Motion in Limine to Suppress Specific Statements is denied.
5. Motion to Dismiss with Brief in Support (roadblock issue) is denied.
6. Notice of Objection to the State's Attempt to Call Any Witness Or To Put on Any Evidence Not Provided to Defendant Through Discovery is sustained by agreement and granted.
7. Request For Hearing as to Any Objection by The State to Defendant's Witness, C. Jeffrey Sifers, as Expert/opinion Witness is sustained by agreement (no objection from State) and granted.
8. Motion to Suppress "Field Sobriety Tests" is sustained and granted.
9. Motion *in Limine* to Suppress Any Prior Crimes Evidence is sustained and granted.
10. Demurrer to the Evidence and Motion to Quash Information (orally amended to add Motion to Dismiss Case for Insufficient Evidence) is sustained and granted, and this case is hereby dismissed with prejudice.
